

Unregistered Motor Vehicle Declaration

TO:

202__ Declaration of Personal Property - MV FORM North Haven Connecticut

Filing Requirement – Any motor vehicle which is not registered in Connecticut shall be subject to property tax in this state if such motor vehicle in the normal course of operation most frequently leaves from and returns to or remains in one or more points within this state, and such motor vehicle shall be subject to such property tax in North Haven within which such motor vehicle in the normal course of operation most frequently leaves from and returns to or remains, provided when the owner of such motor vehicle is a resident of North Haven, it shall be presumed that such motor vehicle most frequently leaves from and returns to or remains in North Haven unless evidence, satisfactory to the North Haven Assessor's Office, is submitted to the contrary.

This declaration must be completed and filed with the North Haven Assessor's Office. Declarations of personal property shall be made annually. Writing "Same as last year" is not acceptable.

Penalty for late filing – Failure to file timely will result in a penalty equal to 25% of the assessment of the personal property. This declaration must be filed or postmarked no later than:

Extension: The Assessor may grant a filing extension *for good cause* (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor in writing by **November 1**.

November 1, 202__

If you no longer own the personal property assessed in your name last year or moved the property out of North Haven, you must return this declaration to the Assessor and provide information related to the name of the new owner of the property or to where you moved the property (see below). Otherwise, the Assessor must assume that you still own and have failed to declare your taxable personal property.
