BOARD OF FIRE COMMISSION MEETING JULY 23, 2019

A meeting of the North Haven Board of Fire Commission was held on Tuesday, July 23, 2019 at 6:00 PM in the Training Room at Northeast Co4, 366 Washington Avenue, North Haven, CT.

Chairman Nuzzolillo called the meeting to order at 6:00 PM. Chairman Nuzzolillo welcomed everyone to the meeting and then led the attendees in the recitation of the Pledge of Allegiance.

Commissioner Criscuolo motioned, with a second from Commissioner Zuccarelli to approve the special meeting minutes of the Board of Fire Commission's Meeting of June 18, 2019.

Chief Januszewski discussed his Chief's Report. He spoke of EMS alarms; current budget, permit fees received and fire marshal office details were discussed. Training within the department was discussed. The sick and injury report was discussed in executive session.

He read the letter on camera and then stated he had not heard back from anyone at this point and will hope to have some kind of answer by the next Board of Fire Commission meeting.

Chief Januszewski discussed the unfinished business in the department. He spoke with regard to the CT OEMS PSAR Application; AFG Application; training facility at 366 Washington Avenue; and lastly, the status of the department's fire apparatus.

Brief discussion was had amongst the commission regarding the unfinished business within the department.

Chief Januszewski spoke of the new business within the fire department. He mentioned the Boy Scout Explorer Program and then turned it over to Deputy Chief Scott Martus to discuss in further detail. Brief discussion was had amongst the commission and they are in full support of this program.
