Chairman Nuzzolillo called the meeting to order at 6:00 PM. Chairman Nuzzolillo welcomed everyone to the meeting and then led the attendees in the recitation of the Pledge of Allegiance.

Chairman Nuzzolillo conducted the Swearing in Ceremony and the oath was read to Mark Santore of West Ridge Co3. The commission welcomed him into the department, be safe and thanked him for his service.
