**AGENDA:**

Mr. Bumsted, Chairman called the meeting of the Inland Wetlands Commission to order at 7:00 PM and introduced the Commission and town staff. Then, Mr. Bumsted asked if there were any changes to the agenda. Mr. Fredricksen stated that there were none.

**PUBLIC HEARINGS:**

1. #I20-01 Application of Vigliotti Construction Co., Applicant, Piepers' Farm, LLC, Owner, relative to 343 Clintonville Road, (Map 69, Lot 55), seeking a Subdivision Referral. Plan Entitled: Subdivision Map, 343 Clintonville Road (CT Route 22), North Haven,

Attorney Timothy Lee with Fasano, Ippolito, Lee & Florentine, LLC in New Haven, presented the application for a Subdivision Referral with no regulated activity proposed. The site is approximately 12.8 acres proposed to be subdivided into two (2) lots, the westernmost proposed at approximately 6.9 acres and the easternmost at approximately 5.9 acres. Mr. Lee stated that if this application is approved, his client, Vigliotti Construction will present an application to the Planning & Zoning Commission for Special Permit and Site Plan Approval. An Elderly Housing Development is proposed for the two parcels, if approved. Mr. Lee presented a drawing of the property including two proposed residential buildings and a clubhouse.

Ms. Megan Raymond, Project Manager of Milone and McBroom described the wetlands on the two parcels. She discussed the pond and vernal pool and explained the existing vegetation, invasive species and wildlife.

Mr. Bumsted asked for public comment.

1. William Richards of 18A North Avenue is concerned with potential road flooding and the brook overflowing.

Mr. Lee and Ms. Raymond, responded to the public comment.
