Ms. Rosalind Page, Land Surveyor, representing Summer Hill Civil Engineers & Land Surveyors in Madison, CT, presented the application for a Subdivision Referral, with no regulated activity proposed. This application, if approved, would result in the subdivision of this 9.77 acre parcel into four (4) lots, the northwesternmost, along Half Mile Road, of which would contain the existing single family residence currently on the parcel.
