SPECIAL BUDGET TOWN MEETING JUNE 10, 2024
REFERENDUM: JUNE 11, 2024

Notice is hereby given, pursuant to Chapter VII, Section 706 of the North Haven Town Charter that A Special Budget Town Meeting of the electors and citizens qualified to vote in town meetings of the Town of North Haven, Connecticut, will be held in the auditorium of the North Haven High School, 221 Elm Street, on Monday, June 10, 2024 at 7:00 P.M. This Town Budget Meeting will conduct the following business:

- 1) To consider and act upon the recommendation of the Board of Finance to take action regarding the budget for the fiscal year July 1, 2024 to June 30, 2025; and
- 2) Pursuant to Section 7-7 of the Connecticut General Statutes, to adjourn said town meeting at its conclusion and to submit the question concerning the adoption of a budget for fiscal year July 1, 2024 to June 30, 2025 to a vote by paper ballot on Tuesday, June 11, 2024, including the establishment of the exact hours of voting at REFERENDUM, pursuant to C.G.S. § 7-9b, that voting will take place between the hours of 6:00 A.M. and 8:00 P.M. at the following North Haven polling place:


ALL DISTRICTS: Mildred Wakeley Rec. Center, 7 Linsley Street

The aforesaid recommendations will be placed on paper ballots as the following question: "Shall the Town of North Haven, in accordance with the recommendation of the Board of Finance, approve and adopt a budget consisting of \$64,022,728 for the Board of Education and \$64,557,603 for the Town Government, for a total amount of \$128,580,331 for the fiscal year July 1, 2024 to June 30, 2025?" Voters approving said question will vote "YES" and those opposing said question will vote "NO".


