- To consider and act upon the recommendations of the Board of 1. Finance and the Board of Selectmen to appropriate \$2,800,000 for the milling and paving of Town roadways. The project shall consist of milling and removal of waste materials, paving and materials, installation of manholes and drainage risers, traffic protection, including signage and police and flag personnel; the appropriation may be spent for design, demolition and construction costs, equipment, furnishings, materials, site improvements, survey costs, architects' fees, engineering fees, other consultants' fees, legal fees, net temporary interest and other financing costs, and other expenses related to the project; to issue bonds or notes and temporary notes of the Town in an amount not to exceed \$2,800,000; to provide that the amount of bonds or notes authorized to be issued shall be reduced by any grants received for the project and not separately appropriated; to authorize the First Selectman and the Treasurer of the Town to determine the amounts, dates, interest rates, maturities, redemption provisions, form and other details of the bonds or notes; and to perform all other acts which are necessary or appropriate to issue the bonds or notes; and, to authorize the First Selectman, the Treasurer and other proper officers of the Town to take all other action which is necessary or desirable to complete the project and to issue bonds or notes to finance the aforesaid appropriation.
- To consider and act upon the recommendations of the Board of Finance and the Board of Selectmen to appropriate \$450,000 for repairs, improvements and replacements to roofs and other structural elements of various Town buildings; including, but not limited to, roof and related repairs to the Walter Gawrych Community Pool; the appropriation may be spent for design, demolition and removal of materials, construction, equipment, materials, site improvements, survey costs, architects' fees, engineering fees, other consultants' fees, legal fees, net temporary interest and other financing costs, and other expenses related to the project; to issue bonds or notes and temporary notes of the Town in an amount not to exceed \$450,000; to provide that the amount of bonds or notes authorized to be issued shall be reduced by any grants received for the project and not separately appropriated; to authorize the First Selectman and the Treasurer of the Town to determine the amounts, dates, interest rates, maturities, redemption provisions, form and other details of the bonds or notes; and to perform all other acts which are necessary or appropriate to issue the bonds or notes; and, to authorize the First Selectman, the Treasurer and other

proper officers of the Town to take all other action which is necessary or desirable to complete the project and to issue bonds or notes to finance the aforesaid appropriation.

To consider and act upon the recommendations of the Board of 3. Finance and the Board of Selectmen to appropriate \$1,250,000 for the acquisition of refuse containers and the related equipment to facilitate curbside collection; the appropriation may be spent for acquisition costs, installation costs, design, engineering and other consultants' fees, legal fees, net temporary interest and other financing costs, and other expenses related to the project; to issue bonds or notes and temporary notes of the Town in an amount not to exceed \$1,250,000; to provide that the amount of bonds or notes authorized to be issued shall be reduced by any grants received for the project and not separately appropriated; to authorize the First Selectman and the Treasurer of the Town to determine the amounts, dates, interest rates, maturities, redemption provisions, form and other details of the bonds or notes; and to perform all other acts which are necessary or appropriate to issue the bonds or notes; and, to authorize the First Selectman, the Treasurer and other proper officers of the Town to take all other action which is necessary or desirable to complete the project and to issue bonds or notes to finance the aforesaid appropriation.

RESOLUTION APPROPRIATING \$2,800,000 FOR THE MILLING AND PAVING OF TOWN ROADWAYS; AND AUTHORIZING THE ISSUE OF \$2,800,000 BONDS AND NOTES TO FINANCE THE APPROPRIATION

RESOLVED,

- (a) That the Town of North Haven appropriate TWO MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$2,800,000) for the milling and paving of Town roadways; the project shall consist of milling and removal of waste materials, paving and materials, installation of manholes and drainage risers, traffic protection, including signage and police and flag personnel. The appropriation may be spent for design, demolition and construction costs, equipment, furnishings, materials, site improvements, survey costs, architects' fees, engineering fees, other consultants' fees, legal fees, net temporary interest and other financing costs, and other expenses related to the project.
- (b) That the Town issue bonds or notes in an amount not to exceed TWO MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$2,800,000) to finance the appropriation for the project. The amount of bonds or notes authorized to be issued shall be reduced by the amount of grants received by the Town for the project. The bonds or notes shall be issued pursuant to Sections 7-369 of the General Statutes of Connecticut, Revision of 1958, as amended, and any other enabling acts. The bonds or notes shall be general obligations of the Town secured by the irrevocable pledge of the full faith and credit of the Town.
- (c) That the Town issue and renew temporary notes from time to time in anticipation of the receipt of the proceeds from the sale of the bonds or notes for the project or the receipt of grants for the project. The amount of the notes outstanding at any time shall not exceed TWO MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$2,800,000). The notes shall be issued pursuant to Section 7-378 of the General Statutes of Connecticut, Revision of 1958, as amended. The notes shall be general obligations of the Town and shall be secured by the irrevocable pledge of the full faith and credit of the Town. The Town shall comply with the provisions of Section 7-378a of the General Statutes with respect to any notes that do not mature within the time permitted by said Section 7-378.
- (d) That the First Selectman and the Treasurer of the Town shall sign any bonds or notes by their manual or facsimile signatures. The law firm of Pullman & Comley, LLC is designated as bond counsel to approve the legality of the bonds or notes. The First Selectman and the Treasurer are authorized to determine the amounts, dates, interest rates, maturities, redemption provisions, form and other details of the bonds or notes; to designate one or more banks or trust companies to be certifying bank, registrar, transfer agent and paying agent
