

**SECTION VI**

**RULES AND REGULATIONS OF THE TOWN OF NORTH HAVEN  
WATER POLLUTION CONTROL AUTHORITY**

**MISCELLANEOUS INDUSTRIAL USERS REGISTRATION  
[Adopted: January 25, 2021]**

**Section 1. Purpose**

The purpose of this regulation is to comply with newly adopted State of Connecticut Department of Energy and Environmental Protection (CT DEEP) re-issuance of the General Permit for Discharges from Miscellaneous Industrial Users (MIU GP) Program. Under this revised program, Miscellaneous Industrial Users must register their facilities with the municipality accepting their Industrial Wastewater Discharges. These program changes apply only to Miscellaneous Industrial Users. Significant Industrial Users (SIU) are still required to coordinate their discharges with CT DEEP directly as has been done in the past.

**Section 2. Definitions**

Definitions shall be the same as the definitions contained in Section 22a-423 of the Connecticut General Statutes, Section 22a-430-3(a) of the Connecticut Regulations of State Agencies, and the Connecticut DEEP General Permit for Discharges from Miscellaneous Industrial Users (MIU GP) issued on September 29, 2020.

**Section 3. Notification**

The owner of the source or activity generating the discharge shall submit notification required under this General Permit. Notification shall be prepared on forms provide by CT DEEP, and submitted to the Town as follows:

The Notification is effective for the entire term of the General Permit Authorization. Any changes to the source or activity, including change in ownership requires submission of a new Notification form reflecting the changes. Notification form, and all applicable attachments must be completed in their entirety, and signed by an authorized responsible corporate officer, and a qualified Professional Engineer or Certified Hazardous Material Manager as necessary.

#### **Section 4. Fees**

The WPCA Board may establish and revise fees for the Town of North Haven's General Permit for Miscellaneous Industrial Users (MIU GP) Regulation. The fees may include, but will not be limited to registration, inspection, and violation fees.

The fees associated with this program as established by the WPCA Board are \$100.00 which shall accompany the initial Notification submission.

#### **Section 5: Discharge Limits**

In order to qualify for registration under the General Permit, all discharges must meet the effluent discharge limitations as defined in the General Permit for Miscellaneous Industrial Users (MIU GP) Program prepared by CT DEEP. Discharges that exceed these limitations do not qualify under the general permit, and must be registered directly with CT DEEP.

#### **Section 6: Monitoring and Recording Requirements**

Depending on the nature of the discharge, and the activities occurring at individual site, sampling and analytical testing is required for some users under this permit program. Parameters and frequency of testing is defined in the General Permit for Miscellaneous Industrial Users (MIU GP) Program. The sample location and type shall be determined based on the General Permit requirements. All Analytical results shall be tabulated and retained at the permittee's principal place of business in Connecticut for at least five years for the date the results were received.

In the event that testing data indicates an exceedance of any of the required parameters, or if the permittee becomes aware of any discharge that could cause problems at the POTW, the permittee shall notify the POTW Authority and the CT DEEP immediately, and include the name and address of the permittee, the maximum daily flow, complete analytical results, and the name and phone number of a contact person at the site familiar with the situation.

#### **Section 7: Reporting Requirements**

Except at the time of Notification, or in the event of an exceedance, no testing data is required to be submitted. All analytical test results shall be submitted upon request of the POTW Authority or the CT DEEP.

#### **Section 8: Additional Requirements**

The requirements articulated in this Section of the North Haven WPCA Rules and Regulations do not represent all requirements under the General Permit. Permittees shall fully comply with all aspects of the General Permit for Miscellaneous Industrial Users (MIU GP) Program as issued and periodically amended by CT DEEP.
