GENERAL INFORMATION ON ROSE LAKE PARK 2024 SEASONAL CAMPING

- Rose Lake Park offers 44 Seasonal Sites on a lottery basis each camping season. The Seasonal Campsite Lottery for 2024 will take place on Saturday, August 26th, 2023 beginning at 3:00 PM in the Sid Ouwinga Pavilion at Rose Lake Park.
- Please verify the site(s) you choose will accommodate your RV before choosing site preferences for the lottery. We are not responsible if your RV is too large for the site chosen. There are a very limited number of sites that will accommodate larger RVs up to 44', as designated below with an *.

- Vehicle Permits are not included with seasonal campsite fee. They must be purchased separately.
- Seasonal campers and their guests must abide by all park rules throughout their stay.
- Electric invoices must be paid monthly, the deposit is applied to the final bill (if owed a refund, a check will be mailed to you).

LOTTERY INFORMATION

Registration for the Seasonal Campsite Lottery will begin on Tuesday, July 25th, 2023. **Advanced registration is required!** Deposits will be accepted from 9:00 AM, July 25th until August 25th at 5:00 PM at the Osceola County Parks Commission office (please see section I below for info). Registration will NOT be available on the day of the lottery or at the parks offices. If the available 44 sites are not reserved during the lottery, guests may choose a remaining site the Monday after the lottery on a first-come first-serve basis.

1. The lottery entry fee is \$200.00. This deposit will be applied to the seasonal campsite chosen (\$100 towards electrical, \$100 towards site fee).
2. Lottery rules will be reviewed by park staff before the lottery begins.
3. The lottery will begin promptly at 3:00 PM.
4. The first name/number drawn will receive the first pick of eligible sites. The second name/number drawn will receive second pick of eligible sites remaining, and so on. The drawing continues until all available sites are chosen and/or there are no more registrations to draw.
5. Once the Lottery Drawing has been completed any seasonal sites remaining will be made available for seasonal reservations beginning on Monday, August 28th, 2023 on a first-come, first-serve basis.
6. If more than 44 entries are registered, a waiting list will be drawn during the lottery process as soon as the 44 available sites have become selected.
7. Entries in the lottery are non-transferable.
8. All registered lottery participants should arrive no later than 2:45 PM the day of the lottery.
9. Seasonal campsites chosen in the lottery are nontransferable.

2024 SEASONAL LOTTERY REGISTRATION

- I. To register, please do one of the following (registration/deposits will not be accepted at the park offices):
 1. Mail a \$200 deposit check or money order and the completed documents (listed in section II) to the Osceola County Parks Commission office at:

 3. Call the office and arrange an appointment for in-person registration (Open: Tuesdays and Thursdays).
- II. In order to register for the Osceola County Parks Seasonal Lottery, you will need to provide:
 - The following completed forms:
 - 2024 Lottery Registration Form
 - 2024 Lottery Policy Acknowledgement Form
 - 2024 Absentee Lottery Registration Form (if will not be present during lottery event)
 - A copy of your registration for your camping unit. (Only one entry may be placed per camping unit within Osceola County Parks); if your camping unit is not registered, please complete the 2024 Lottery Internal Camping Unit Number Request Form for assignment of an internal number to be used for entry in the lottery.
 - A copy of your valid photo identification. This ID must match the name on the registration for the camping unit.

- A deposit of \$200.00 for each camping unit registered. The deposit may be paid by cash, check, or credit/debit card (additional service fee). Returned insufficient fund checks will be considered a forfeiture of your selected seasonal campsite and charged \$25 bounced check fee.

Additional Notes:

- If a site is chosen, the deposit will be applied toward the expense of the seasonal campsite and electrical usage (\$100 each).
- If your name is not drawn for one of the 44 sites being filled, you will receive a full deposit refund and be placed on the waiting list in the order drawn during the lottery. If a seasonal site opens up, the individuals on the waitlist will be notified in order drawn during the lottery.

ABSENTEE LOTTERY REGISTRATION

If you are unable to attend the lottery for any reason, please follow the steps above for lottery registration. In addition, please fill out an absentee registration form, which can be acquired at the Rose Lake Park office or Osceola County Parks Commission office. Please document your top choices in order of preference for sites on your absentee card. When your lottery name/number is chosen, the first available site on your list will be assigned. If all of the sites requested are previously assigned, a spot will be held from the 44 available and selected by park staff after all other entries have been assigned.

If you wish to assign an individual to choose a site for you, their information must be listed on your absentee registration card. Your assignee will be given the final say, regardless of the choices listed on your absentee card. An assigned individual may be required to show ID before making the selection for an absent registrant.

If you have not completed an absentee form and are not present when your name is called during the lottery, it will be considered that you are passing on any remaining sites and the next name will be called. You will not be saved a seasonal campsite and a \$25 administrative fee will be assessed upon return of your deposit.

LOTTERY DAY REFUND PROCEDURE

A \$25 Administrative Fee will be assessed to any lottery registrant drawn whom does not choose a site. If your name is not drawn for 1 of the 44 available sites, you will automatically receive a full refund of deposit. Refunds will not be returned as a credit at the park. Deposits requiring refunds will be processed by check within 30-45 days of the lottery.

2024 POST LOTTERY SEASONAL CAMPING INFORMATION

- The anticipated Osceola County Parks 2024 Season is May 3rd – Sept. 28th
- It is anticipated that seasonal campers may arrive at the campground to set up your camping unit beginning at 9:00 AM on Friday, May 3rd, 2024, please note this is subject to change. Please check our website and/or Facebook page or call the Parks Office at 231-832-6130 for up-to-date information on the opening date for camping at Osceola County Parks.
- Balance in full for your seasonal campsite must be paid by May 17th, 2024, or when you arrive to set up your camper, whichever is first.
- Payments/Installments may be made throughout the off-season thru the Osceola County Parks Office. Off-season payments may be made with a credit/debit card by calling (231) 832-6130 or by check/money order sent to:

- If your site is not paid in full by office closing time on May 17th, 2024, forfeiture of your deposit and seasonal campsite will occur. The campsite will become available to other guests at this time.

ROSE LAKE PARK SEASONAL CAMPSITE CANCELLATION INFORMATION

- Cancellation requests received by April 27th, 2024 will be processed, less a \$50 administrative fee from the site deposit fee.
- Cancellation requests received after April 27th, 2024 will not be eligible for a refund on the site deposit or payments, however the \$100 electrical deposit will be returned minus any usage fees.

SEASONAL CAMPER - WAIT LIST ADMINISTRATION

If more than 44 registrations are received for the lottery, those that do not receive one of the 44 available sites will continue to be drawn and a wait list order established. If a seasonal cancellation occurs, the first registrant on the wait list will be called and offered the site. The list will continue to be followed for any/all cancellations. All registrants from the lottery will be allowed to be added to the wait list in the order they are drawn. If less than 30 guests are on the wait list, additional names will be accepted to the list on a first come, first serve basis up to a total of 30 guests. Guests that received a site during the lottery are not eligible to be placed on the wait list. Guests that turn down a site offered during the lottery may be added to the end of the wait list if the request is received immediately following the conclusion of the lottery.

2024 ABSENTEE LOTTERY REGISTRATION FORM

If you are unable to attend the lottery for any reason, please complete the Absentee Lottery Registration Form located below and turn it in with your deposit during the registration process.

- If you have not completed an absentee form and are not present when your name is called during the lottery, it will be considered that you are passing on any remaining sites and the next name will be called. You will not be saved a campsite and a \$25 administrative fee will be assessed upon return of your deposit.
- An absentee lottery registration form must be accompanied by the following items for your registration to be complete:
 - Copy of Driver’s License
 - Copy of registration for camping unit, matching the name on the Driver’s License (or complete the Internal Camping Unit Number Request Form, if unit is not registered).
 - \$200 Deposit: check, money order, or call Parks Commission office with credit card number (+3% fee)
 - Signed Lottery Policy Acknowledgement
 - Absentee Registration Form (below) completed with one of two options:
 1. *You choose:* Document your top choices for sites on the card below. When your lottery entry is chosen, your first available site will be assigned. If all of the sites requested are previously assigned, a spot will be held from the 44 available and selected by park staff after all other entries have been assigned.
 2. *Assign an individual to choose a site for you:* List the individual’s information below on your absentee registration card. Your assignee will be given the final say, regardless of the choices listed on your absentee card. An assigned individual may be required to show ID before making the selection for an absent registrant.

- A copy of your valid photo identification. This ID must match the name on the registration for the camping unit.
- A deposit of \$200.00 for each camping unit registered. The deposit may be paid by cash, check/money order, or credit/debit card (additional service fee). Returned insufficient fund checks will be considered a forfeiture of your selected seasonal campsite and charged a \$25 fee. (If a site is chosen, the deposit will be applied toward the expense of your seasonal campsite and electrical).
- If your name is not drawn for 1 of the 44 seasonal sites being filled, you will receive a full refund and be placed on the waiting list in the order drawn during the lottery.
