

SKATE PLAZA RULES

SKATE PLAZA HOURS:

8:00AM to 8:00PM daily.

USER REQUIREMENTS:

ALL USERS OF ANY AGE MUST WEAR A HELMET, ELBOW PADS, AND KNEE PADS AT ALL TIMES.

Adult supervision is required for skaters younger than 12-years of age.

This Skate Plaza is unsupervised. Use of the facility is a potentially hazardous recreational activity used by both experienced and inexperienced skaters. Users voluntarily assume all risks and dangers associated with and incidental to this facility.

GENERAL GUIDELINES:

Non-Motorized Skateboards, roller skates, in-line skates and scooters only. Bicycles and motorized vehicles are NOT allowed.

Spectators are not allowed in skating area.

Skating is not permitted during inclement weather or when the plaza is wet.

PROHIBITED ACTIVITIES:

No glass containers, food, or beverages in fenced area.

No amplified music. All noise must be kept at a respectable level.

No additional obstacles, including ramps, jumps, or other materials may be brought on to the plaza. Modification or altering of plaza features or skating surface is not permitted.

No littering or defacing of District property (graffiti, stickers, etc.)

No alcohol, smoking or vaping.

No animals.

No private instructions, competitive, or demonstration events unless organized or permitted through the Park District.

CODE OF CONDUCT:

Engaging in reckless and boisterous behavior, including but not limited to, the use of profanity, aggressive or threatening words or actions, tandem riding, horseplay, or any other activity which could endanger the safety of persons using the Skate Plaza is prohibited.

SAFETY FIRST - know your abilities and skate within them. Exercise common sense and courtesy to others. Risky moves, skating against traffic and not watching out for other skaters is dangerous and can cause injuries.

ANY PERSONS FAILING TO WEAR A HELMET, ELBOW PADS AND KNEE PADS AT ALL TIMES OR FAILING TO FOLLOW ANY OF THE PARK RULES OR REGULATIONS SET FORTH WITHIN THE RANCHO SIMI RECREATION AND PARK DISTRICTS ORDINANCE NO.3 WILL BE SUBJECT TO CITATION. SUCH VIOLATION IS A MISDEMEANOR UNLESS THE PARK RANGER OR OTHER PEACE OFFICER SPECIFIES ON THE CITATION THAT THE VIOLATION IS AN INFRACTION AS PROVIDED FOR WITHIN THE CALIFORNIA PUBLIC RESOURCE CODE.
