2. **THE PLEDGE OF ALLEGIANCE** to the flag was led by Supervisor Braun.

3. COMMENTS FROM THE PUBLIC:

County Commissioner Lisa Coney announced that the Saginaw County Board of Commissioners approved bidding on the property adjacent to Imerman Memorial Park for possible enlarging of the park. She also announced the Board approved two grants for Habitat for Humanity for housing and housing repairs for Saginaw County Residents. Janet Deneen announced the arrival of Vice President Nominee JD Vance speaking tomorrow at Center Courts in Saginaw Township and that all Saginaw Townships Board members are invited to attend.

He also spoke on the 65th Anniversary of Saginaw Townships Fire Department and commended them for the growth that they have had in the last 65 years. With it being National Responders day, he also commended all those individuals and thanked them for their hard work and dedication.

<u>Trustees</u> – Trustee Ryan announced that all 3 Saginaw Township Schools have qualified for play offs, Heritage High School, Valley Lutheran and Nouvel Catholic. Trustee Reppuhn announced that Real Estate sales have slowed down.

<u>Manager</u> – Manager Rombalski announced that we currently have 7 new recruits in the fire academy. He also spoke on the Police Department transferring over to a .gov email platform. He announced that no Saginaw Township tax payer dollars are going to fund the new Wastewater Treatment Facility. He also announced that Center Courts is being rented as any other would be for the Vice President Nominee JD Vance coming tomorrow. There is a lot of Safety precautions being taken for this event along with 9 Saginaw Townships Officers assisting with the event.
