WHAT IS BEING ASKED OF THE AGENCY?								

To approve Resolution UR-2022.01 -Purchase of the 0.11 acre vacant lot, located in the downtown area, adjacent to the previously purchased parking lot. The subject lot is identified as Tax Lot 5400 in Section 17DC of T25S, R5W, Property ID No. R55904.

EXPLANATION

As part of the Urban Renewal/TIF (Tax Increment Finance) Plan, Sections VI, VII and VII require a resolution approving the amendment to the Plan approving the acquisition of the property.

To accommodate the most effective parking design to benefit the downtown area, the property owners have agreed to sell the property to the URA/TIF for \$40,000. This amount is an average amount of the surrounding assessed property values. Title Company fees and recording fees, will be in addition to the purchase price \$40,000.

WHEREAS, the City Council pursuant to the requirements of ORS Chapter 457 approved the Sutherlin Tax Increment Finance Plan dated June 11, 2020; and

WHEREAS, Section VI of the Plan authorizes certain project activities within the Sutherlin Tax Increment Finance Area; and

WHEREAS, Section VIII of the Plan pertains to acquisiton and ORS 457.085((2)(g) requires properties to be acquired to be included in the Plan; and

WHEREAS, Section VII of the Plan authorizes minor amendments to the Plan and identifying property to be acquired is a minor amendment to the Plan; and

WHEREAS, the Agency intends to purchase the property identified as (Tax Lot 5400 in Section 17DC of T25S, R5W, Property ID No. R55904).

NOW THEREFORE, BE IT RESOLVED by the Urban Renewal Agency of the City of Sutherlin as follows:

- Section 1. The recitals of this resolution are adopted as additional findings and are incorporated herein as if fully set forth.
- Section 2. Projects for this property are identified in the Sutherlin Tax Increment Finance Plan.
- Section 3. The Agency approves the proposed acquisition of property as described above, attached hereto and incorporated by reference herein as if fully set forth.
- Section 4. The Agency directs staff to take any action necessary to implement this resolution. The City Manager of Sutherlin is authorized to sign the

agreement as shown in above and to accept the property on behalf of the Agency.

Section 5. This resolution shall be deemed a minor amendment to the Sutherlin Tax Increment Finance Plan.

Section 6. This resolution shall be effective as of the date of adoption.







WHAT IS BEING ASKED OF THE AGENCY?								

The Urban Renewal Agency is being asked to support the Oregon Revitalization Grant Application submitted by SDDI for improvements to the Old Bank Building, located in the northeast corner of the intersection at W. Central Avenue and N. State Street, in the Downtown District within the city limits of Sutherlin, approve match funding and finance the reimbursement grant.

EXPLANATION

As part of the Urban Renewal/TIF (Tax Increment Finance) Plan, Downtown Development/Redevelopment was identified as one of the five project categories.

As part of the Urban Renewal Downtown Development/Redevelopment, SDDI would like to request 30% match dollars to support their \$200,000 Oregon Revitalization Grant Application. the grant application will outline proposed improvements as follows; a new roof, HVAC system removal and installation, sprinkler system installation, and interior demo/asbestos removal. Proposed improvements will bring the building up to code allowing it to be occupied with commercial and residential uses as permitted, improving the economic vitality in the downtown district.

As a reimbursement grant, SDDI requests the Sutherlin Urban Renewal Agency to provide initial funding, to be reimbursed by SDDI throughout the grant process. City Staff will prepare an Intergovernmental Agreement (IGA) between SDDI and the Urban Renewal Agency. Resolution 2022.02 would authoriz the City Manager to sign IGA.

City Staff holds a SDDI Board position and will be the financial contact on the grant.

A RESOLUTION SUPPORTING AN OREGON REVITALIZATION GRANT APPLICATION BEING SUBMITTED BY THE SUTHERLIN DOWNTOWN DEVELOPMENT INC. (SDDI) FOR IMPROVEMENTS TO THE OLD BANK BUILDING IN SUTHERLIN, OREGON.

WHEREAS, the Oregon Main Street is accepting applications for the Oregon Revitalization Grant for communities that participate in the Oregon Main Street Network;

WHEREAS, SDDI will apply for grant funds in the amount of \$200,000 to pay for critical improvements to the Old Bank Building, while the new owners execute and pay for additional building improvements to complete the expected restoration. This building is located at the northeast corner of the intersection at W. Central Avenue and N. State Street, in the downtown district within the city limits of Sutherlin;

WHEREAS, the grant application will outline proposed improvements as follows; a new roof, HVAC system removal and installation, sprinkler system installation, and interior demo/asbestos removal. Proposed improvements will bring the building up to code allowing it to be occupied with commercial and residential uses as permitted, improving the economic vitality in the downtown district;

WHEREAS, the Sutherlin Urban Renewal Agency desires to participate in this grant program to the greatest extent possible as a means of providing improvements and enhancements to the Old Bank Building;

WHEREAS, the Sutherlin Urban Renewal Agency will provide match funding of 30%, not to exceed \$60,000 towards SDDI's grant application;

WHEREAS, the Sutherlin Urban Renewal Agency will provide initial funding to be reimbursed by SDDI throughout the grant process. Urban Renewal Agency will have a signed Intergovernmental Agreement with SDDI;

WHEREAS, the City Council pursuant to the requirements of ORS Chapter 457 approved the Sutherlin Tax Increment Finance Plan dated June 11, 2020; and

WHEREAS, Section VI of the Plan authorizes certain project activities within the Sutherlin Tax Increment Finance Area.
