WHAT IS BEING ASKED OF THE AGENCY?					
The Urban Renewal Agency is being asked to consider a minor amendment to the Urban Renewal District to include monies for Public Safety Structural Improvements to the Sutherlin Police					

EXPLANATION

Department and the Sutherlin Fire Department buildings.

As part of the Urban Renewal/TIF (Tax Increment Finance) Plan, Downtown Development/Redevelopment was identified as one of the five project categories.

The Sutherlin Police and Fire Departments both received grant funds for Seismic Rehabilitation Retrofits. In conjunction with the seismic rehabilitation, the much-needed additional facility improvements fall within the urban renewal district criteria as described in the attached.

## Unquestionable City Improvements Worthy of Urban Renewal Agency Support

In the course of establishing the Sutherlin Urban Renewal District, public buildings were not considered to be a benefactor of Urban Renewal (UR) assistance. In the interim, a significant public safety grant for building improvements has been awarded to the City of Sutherlin Police and Fire Departments which has now created a unique and time-constrained opportunity to complete a broader city facilities improvement.

Therefore, the "unquestionable" reasons for amending our Urban Renewal Plan and expending UR monies are outlined below:

- 1. Both the Police and Fire Departments are, as required, within the boundaries of the urban renewal district.
- 2. Both buildings are not only in the urban renewal district but also in the heart of our downtown. The current plan has identified such building improvements in the heart of our downtown as one of our highest priorities. Our plan depicts mostly along Central Avenue from Calapooia Street going East to Umatilla. Further, if one were to look at the planned-for and completed improvements along this three-block corridor, they would see that almost all the work thus far is on the block at Calapooia, with one project occurring now on the corner of State Street and none from State Street to Umpqua Street. Therefore, the current \$4.5M federal grant coupled with \$1.5M new urban renewal dollars, would complete safety, structural, and aesthetic improvements lasting for 30 or more years into the future and show for all to see a book-end downtown beautification. In summary, this is again, a "one-time" opportunity to take advantage of federal funding provided to upgrade and reconfigure public safety facilities while also completing years-needed modernization and repair of interior and exterior of City of Sutherlin buildings in the heart of our downtown. While not fully "blighted" currently, one cursory walk-thru would easily show clear signs of deterioration generally thought to be unacceptable in public buildings.
- 3. As referenced above, the eradication of blight is a significant expectation built into the UR plan. In another context, a "higher quality of life" is almost always embodied where there is a vibrant downtown thus, resulting in a "Sense of Place" community. The downtown subsequently serves as a "canary in the mine" so to speak demonstrating the overall attitude of the people and the economic activity necessary in constructing a "sense of place" community. A "Sense of Place" community cannot coexist with blight, high crime, and a deteriorating downtown. Therefore, this work, when completed, will have significantly and positively improved the "vibrancy of downtown", establishing an environment restraining blighted conditions, and eliminating the appearance of dilapidated facilities. The city's public safety response systems across multiple critical functions of effective public safety services, both in downtown and throughout the community, have been improved for decades. Ultimately, all of this proposed most-significantly contributes to the eradication of blight.
- 4. Finally, proportionally, this \$1.5M request comes as a "minor amendment" and represents less than 10% of the fully anticipated UR expenditures throughout the life of the district.

# **RESOLUTION NO. UR-2024.01**

# A RESOLUTION ADOPTING A SUPPLEMENTAL BUDGET ADJUSTMENT, AMENDING THE 2023-2024 BUDGET

## The Sutherlin Urban Renewal Agency finds that:

- A. That ORS 294.473 provides the procedures for public governing bodies to adopt supplemental budget adjustments when estimated expenditures differ by more than ten percent from the expenditures in the budget as most recently amended prior to the supplemental budget adjustment.
- B. The procedure includes the municipal corporation providing notice of a supplemental budget adjustment hearing and holding a public hearing on the supplemental budget adjustment prior to adopting a resolution to change the budget by more than ten percent.
- C. Public notice has been provided as required by ORS 294.473 and a public hearing related to the supplemental budget adjustment was held on April 8, 2024, and
- D. Due to unknown events at the time of adoption, fiscal year 2023-24 budget requires adjustment including but not limited to the following:
  - a. Urban Renewal Debt Service Fund
    - i. This supplemental budget makes changes to allow for partial repayment of the Line of Credit which has been extended by the City of Sutherlin, based on the Tax Revenue received. The amount was unforeseeable at the time that the budget was prepared.

# NOW, THEREFORE, based upon the above findings,

# BE IT RESOLVED by the Sutherlin Urban Renewal Agency as follows:

Section 1. That the budget for the Sutherlin Urban Renewal Agency for the fiscal year 2023-2024, which was adopted by the Agency on June 12, 2023 and is now on file in the office of the City Recorder of the City of Sutherlin, be hereby amended as follows:

# WHAT IS BEING ASKED OF THE AGENCY?

The Urban Renewal Agency is being asked to review and discuss options for a grant funding request received from 117B W. Central Ave. The subject lot is located in the downtown area, identified as Tax Lot 7100 in Section 17DC of T25S, R5W, Property ID No. R55981.

#### **EXPLANATION**

As part of the Urban Renewal/TIF (Tax Increment Finance) Plan, Downtown Development/Redevelopment was identified as one of the five project categories.

We have received an application for façade improvements at 117B W. Central Ave. The applicant/owner has submitted a request for \$25,000 for the façade improvements. The applicant/owner currently has contracted the services of Buglin Heights Drafting for the architectural drawings of the façade improvements. Based on the lineal frontage of the business, the application qualifies for \$25,000.

At the Urban Renewal Task Force meeting held on March 20, 2024, the Task Force made a recommendation to the Urban Renewal Agency to approve the funding request for the Façade Improvement located at 117B W. Central Ave.

WHAT IS BEING ASKED OF THE AGENCY?					

The Urban Renewal Agency is being asked to consider a development proposal for the Everett Property.

#### **EXPLANATION**

Upon our early urban renewal creation, in July of 2022, the URA made three initial bold decisions with the purpose of demonstrating and indeed, visually showing examples of how these projects could serve as a catalyst for improving the downtown.

These three project investments are:

- 1. Providing incentive funding to bring Backside Outpost to downtown,
- 2. Initiate a grant program to incentivize business owners to make beautification and modernization changes to the front and interior of their businesses, and
- 3. Moved to purchase a small lot with the specific intent to incite new investment and seek the possibility of inciting the establishment of a food-cart village at the corner of Calapooia and Everett streets.

Projects #1 and #2 above have exceeded our expectations and now #3 has arrived just as we had anticipated. This specific project, again, was identified as one of five project categories.

As referenced above, therefore, a redevelopment/development proposal was received from Lucas Main Construction / Richard Lundstrom / Foreal Development, LLC on properties identified as Tax Lots 11100 and 11200 in Section 17DC of T25S, R5W, Property ID No. R56219, R56226 and R56212, purchased in July, 2022, located at the corner of S. Calapooia and W. Everett.

The proposal received from Lucas Main Construction / Richard Lundstrom / Foreal Development, LLC, proposes a professional, well-designed space for the community to meet and enjoy good food and activities together. Our proposal consists of a 1600 SF building with roll up doors for an open-air feel, including a beer garden and food service, no cost video games for kids, and an adults ax throwing section.

In addition, the proposal includes another 1000 SF covered patio area with outdoor tables and portable heaters in the colder months. There will additionally be four permanent food trucks/venders on site for a nice variety of cuisines. Areas would also be provided for live music and potentially a small mini golf area. Wifi will be provided for all patrons. The area will be fenced with unobtrusive but secure/locking fencing.

The proposal also includes demolition.

The Urban Renewal Task Force held a meeting on March 20, 2024, reviewed and discussed the proposal submitted by Lucas Main Construction / Richard Lundstrom / Foreal Development LLC, and made a recommendation Urban to the Renewal Agency to approve the request redevelopment/development of the W. Everett Property. Additional development parameters were proposed by staff to include the possibility of waived System Development Charges or a portion thereof, deeding the land to the developers Lucas Main Construction / Richard Lundstrom / Foreal Development, LLC over a period of time of successful business operations (i. e. 5-years), and to negotiate dump fees for the demolition of the existing transmission shop.
