The City of Union is glad to have you as a resident. Any questions you may have pertaining to the city may be directed to City Hall, located at 10 E. Locust, phone 636- 583-3600.

VOTING

You must be a registered voter to vote in City elections. Please register at the County Clerk's office, located on the second floor of the Franklin County Government Center, Locust and Church. phone 636-583-6364.

UTILITIES

Your water and sewer service are supplied from the municipal system and is billed and payable monthly at City Hall. You must make application at City Hall for this service. There is a \$100.00 deposit required for the water service when renting. The deposit will be on the account until such time as the renter moves. The deposit will then be applied to any remaining balance on the account then the remaining will be forwarded to the new address. It is the customer's obligation to notify City Hall when they vacate so a final bill can be read. The water bills also contain charges for residential trash collection. Water meters are read on or near the 15th of each month. The bills are then processed and mailed on the last working day of the same month. Payment is due when billed and bills shall be considered 'delinquent' after the 15th day of that month; a 10% penalty will be applied to all 'delinquent' balances. Accounts beyond 15 days 'delinquent' are subject to disconnection without further notice and an additional \$30.00 will be charged for this disconnection. (All bills not paid within thirty days of mailing are subject to disconnect.)

GARBAGE AND REFUSE

Holidays which fall during the week will only affect collections after the holiday. All pickups prior to the holiday will remain on the regular schedule. Trash is picked up Monday – Friday.

Yard Waste Collection:

Jan. Feb. Mar: 2nd Wed.

Apr. May. June. Oct. Nov: 1st, 2nd, 3rd, & 4th Wed.

Jul. Aug. Sept Dec: 2nd & 4th, Wed.

DOGS

Dogs are forbidden to run at large and should be vaccinated.

CITY TAXES

You will be assessed each year on your Real Estate and Personal Property. New residents should register with the Franklin County Assessor, located in the Franklin County Government center, 636-583-6346 to be assessed. City taxes are included within your county tax bill and collected by Franklin County payable by December 31st annually.

PARKING

City Ordinance requires that all parking of motor vehicles be parallel and that no parking be permitted within 15 feet of a fire hydrant and 10 feet of the fire department buildings. Parking is limited to 2 hours in the downtown area from 8:00 am. to 5:00 p.m. Monday through Friday. Parking outside these times is unlimited.

SPEED LIMIT

The speed limit in the city is 30 MPH, unless otherwise posted.

WEEDS

It is the duty of the occupant or owner of any property in Union to cut and remove the weeds growing thereon or upon any adjacent street sidewalk or alley.

CONSTRUCTION

Permits are required from the city before any new building construction or alteration or change in electrical service can be made. Applications for construction permits are available at City Hall.
