**CALL TO ORDER:** The Upshur County Farmland Protection Board meeting was called to order at 6:12 p.m. by Lowell Peterson, Chairman.

**APPROVAL OF MINUTES:** Motion by Jennifer Bostian, seconded by Todd Payne, the Board moved to approve the minutes from December 2021 as presented. **Motion passed.** 

#### **BUSINESS ITEMS - UPDATE/ACTION ITEMS:**

Ranking Sheet Wording- While working on ranking sheets for the new applications, Mimi was curious about the wording for the working farm points on the ranking sheet. To qualify as a farm for the Assessor's office Farm Valuation, you are required to produce \$1,000. Since they are awarded points for having a farm valuation approval with the assessor's office in a different category on the ranking sheet, Mimi was asking for clarification on how they were going to determine a working farm with the income of only \$1,000. Todd Payne explained that when they revised the ranking sheet, he wanted it to state that a farm must be actively farmed and making at least \$1,000 in income from their agricultural products. This statement was added to ensure that the farm is a working farm and not just a piece of farmland. With the ranking sheet now reflecting that assessment for rating, it was requested by the board to add that question to the Application for the owners applying to answer. The farm income used must be from the calendar year prior to the Application date.

**Queen easement – Status update**— Yellow book appraisals requests have been sent for the Queen easement. Todd made the motion that Mimi can accept the lower bid on the yellow book appraisal to proceed with the Queen easement. Laura Rusmisell seconded the motion; **Motion passed**.

FY22 Applications for Funding Consideration- Mimi Riffle presented the board with the two applications that have been received and ranked. Todd Payne brought the 3<sup>rd</sup> application that was submitted to him in December for review. Herbert and Twila McClain application will need to be broken down and ranked for the review of the board. Mimi will work with Amy on ranking and reviewing the McClain Application before the March 10<sup>th</sup> meeting. The board proceeded to review the application for David Hinkle and The Estate of Amelia Derico. Mimi or Amy will verify that the Derico Farm produced more than \$1,000 in income because that answer is unclear. The applications were tabled to March 10<sup>th</sup> meeting for final review once McClain's application is reviewed and ranked and the Derico income is verified.

#### FINANCIAL MATTERS - UPDATE/ACTION ITEMS:

Financial overview was prepared by John Sencindiver and passed out at the meeting for viewing. Jennifer Bostian made the motion to approve the report as presented, Arley Robinson seconded the motion. **Motion passed**.

**OTHER BUSINESS:** Amy addressed that currently the Assessor's office is using the classification code of 112 on their land use for the easements. Mimi will call and speak with the Assessor about changing the coding to 114 for Farmland Protection. This coding is for Conservation Easements throughout the state.

Amy Moloney also addressed that the State Authority has gotten their internet pages moved and up and running. She requested from the board that this job be moved to Mimi now that she is handling the Administrative part for the board. Amy would forward the passcode to maintain the website. It would be a good idea to load the current application, ranking sheet, and promo stuff to this new web page. The board agreed, as did Mimi, to make this change happen.
