Mr. Howard,

A complaint was filed with the Upshur County Safe Structures and Sites Board in regards to David Miller's property located in Banks Tax District -Tax Map 4 - Parcel Number 2 on June 8, 2021. Specific recommendations of the Board include correction of any health and safety hazards, including but not limited to the removal and proper disposal of any debris, trash, junk vehicles and/or removal and proper disposal of any environmental hazards. The County's Safe Structures and Sites Board sent correspondence to Mr. Bolyard, Estate Administrator, in regards to the properties' condition on the following dates:

- July 13, 2021 --- Notice of Visit
- August 16, 2021 --- Notice of Required Action
- October 15, 2021 --- Extension
- November 15, 2021 --- Extension
- December 16, 2021 Petition for Order

After no progress was made in improving the condition of the property, the Safe Structures and Sites Board turned this case over to the Upshur County Commission. The Upshur County Commission reviewed photographs of the property taken on December 15, 2021 and the Petition for Order during a regularly scheduled Commission Meetings on January 13, 2022 and January 20, 2022. After speaking with Gloria Post, paralegal for Davis Funeral Home, on January 19, 2022, I informed the Commission of Mr. Bolyard's intent as Administrator to sell the property. After discussion, the Commission voted to re-evaluate the status of the property after 30 calendar days. Therefore, the Petition for Order was considered again during the Commission Meeting scheduled for February 24, 2022. During this meeting, the Commission was advised the property was sold and the County Clerk's office was waiting for the executed deed. The Commission voted to discuss a timeline for clean-up upon recording of the deed, which was recorded on May 5, 2022.

Provisions of the Safe Sites and Structures Ordinance allow members of the Enforcement Board to visit, review, photograph and/or obtain soil samples of the property in question in order to perform an

investigation. Please be advised that a site visit for the property in question has been scheduled for May 25, 2022 9:30 a.m. The owner of the property and/or a representative of the property owner are welcome and encouraged to be present for this site visit. Photographs from the site visit will be reviewed by the Commission during their regularly scheduled Commission Meeting on Thursday, June 2, 2022 at 9:45 a.m. These meetings are open to the public and you are encouraged to attend.

Mon Power and Potomac Edison Now Subscribing Solar Energy Customers in West Virginia

Companies plan to construct 50 megawatts of clean, renewable solar generation

FAIRMONT, W. Va. – Mon Power and Potomac Edison, subsidiaries of FirstEnergy Corp. (NYSE: FE), are accepting customer commitments to purchase solar renewable energy credits (SRECs) from five utility-scale solar facilities planned for the companies' West Virginia service territory. The companies recently received conditional approval from the Public Service Commission of West Virginia for the five projects, which will together total 50 megawatts of renewable solar generation to help make West Virginia more attractive for business development.

SRECs are certificates that represent the environmental attributes of solar power and prove solar energy was generated on the purchasers' behalf. For every megawatt hour of solar energy generated, one SREC is produced. When fully operational, the five projects planned by Mon Power and Potomac Edison are expected to create more than 87,000 SRECs per year.

With an overall subscription cost of 4 cents per kilowatt hour in addition to normal rates, customers will be able to choose from a variety of SREC subscription levels and term lengths with pricing options that allow for broad participation in the West Virginia solar program. Commercial and industrial customers will be able to choose a subscription level that reflects a percentage of their monthly energy consumption. Residential customers can support

the program by purchasing a SREC over time at monthly levels of 50 kilowatt hours (\$2 per month), 100 kilowatt hours (\$4 per month), 200 kilowatt hours (\$8 per month) or more.

When Mon Power and Potomac Edison have obtained customer commitments for 85% of the renewable energy credits generated by a solar facility, the companies will seek final approval from the commission for a modest ratepayer surcharge to cover the balance of the project costs and begin full-scale construction. Mon Power and Potomac Edison customers who make a commitment for SRECs now are not expected to begin incurring charges until early 2024.

"We are excited for our solar program to get underway and look forward to connecting with customers who have expressed interest in solar power and supporting renewable energy in West Virginia," said Jim Myers, president of FirstEnergy's West Virginia operations.

The companies' solar program supports a 2020 bill passed by the West Virginia Legislature that authorizes electric utilities to own and operate up to 200 megawatts of solar renewable generation facilities to help meet the state's electricity needs. The addition of new renewable generation also encourages economic development in West Virginia, as a growing number of companies require that a portion of the electricity they purchase be generated by renewable sources.

Mon Power will build, own and operate the five solar facilities, which are located on property owned by Mon Power or its affiliates. The locations include:

- A 26-acre reclaimed ash disposal site in Berkeley County
- A 51-acre site adjacent to a Mon Power substation in Hancock County
- A 27-acre retired ash disposal site in Marion County
- A 95-acre site in Monongalia County adjacent to Fort Martin Power Station
- A 44-acre reclaimed strip mine property in Tucker County

Meeting: Called to order at 5:35 p.m. and minutes from the March meeting were approved.

Upshur County Trails Update:

On April 2, 2022, a bridge was added to the new trail segment.

The Trail Clean-Up day on April 9, 2022, which was part of the West Virginia DEP Make It Shine Day, was very successful with 9 volunteers. The Fairy Garden decorating will be rescheduled, possibly in June.

Jeremiah McCourt reported that he has attempted to contact Eric Hawkinberry on several occasions about hosting a NICA race on the trails, but has not had a response.

Trail purchases of approximately \$710 from the trail funds for bridge building materials and plastic trail markers were approved.

Jeremiah McCourt reported that someone was interested in possibly hosting a 24 hour trail run race on the Upshur County Trails. Rachel Weber recommended starting with a shorter race distance. In addition, she stated that she wants to run this by the trails group before this is approved.

Director's Report:

The gate will be coming off of the bathroom at the pavilion in a few weeks.

Jeremiah McCourt reported that he is applying for funding and submitting an application to build a low-ropes obstacle course in the area of the amphitheater. He is looking into Alpine Tower International to build the 7-obstacle course. He assured the committee that the course will not affect the trails.

He will be meeting with the Rotary Club in June and will possibly request funding for new playground equipment.

The pool is being painted and new diving boards have arrived. The pool opening day will possibly be May 28, 2022 for the public and May 22, 2022 for parties.

He reported that he is looking into Stockmeier Urehanes to repair the tennis courts. County Commission will need to approve.

Eric Jett is planning to partner with Upshur County Parks and Recreation to hold a sprint triathlon in August. Jeremiah McCourt stated that he wants to turn this into a Wellness Weekend, with Saint Joseph's Hospital present to do health screenings, possible Highland Games, Strongman Competition, and a Color Run 5K.

Disc Golf Update:

The disc golf tournament is tentatively scheduled for May 28, 2022, and will be open for 36 players with \$25 entry fee. They are looking for sponsors for each tee at \$100/tee.

J.J. Ford will be making directional signs for the disc golf course. The material has arrived for the signs.
