



Financial Report updates: The Upshur County Trails have added \$400 in donations and \$500 from the WesMonTy Grant.

#### **Upshur County Trails updates:**

- A public trail work day took place in November 2022, in which approximately 20 WVWC students volunteered. The students are interested in regular volunteer opportunities with the Upshur County Trails.
- \$500 was received to start work on the WesMonTy Grant projects, which will include bridging drainage areas on the trails for soil conservation and planting native plants. An advance of \$1,500 from the Upshur County Trail funds was approved to complete the WesMonTy Grant project. This \$1,500 will be returned to the Upshur County Trails funds after the project end date of May 31, 2023.
