Timber Sale Bid Notice
Selbyville Youth Camp Property and Alec Ross on Brooks Hill Road and near
Rt 151 in Selbyville, Upshur County, WV

Preparations are final for a timber sale on the property of the Selbyville Youth Camp and Alec Ross. The total area marked for harvest is a 66 acre portion of two properties near Selbyville WV. The properties are presently accessed by Upshur County Route 11/17, Brooks Hill Road in Banks District. This prospectus is to provide sufficient information to enable prospective bidders to decide whether further investigation is warranted.

- The entire contents of **1,228 trees** with a total volume of **242,189** board feet are marked for cutting in the sale area. See attached for individual species breakdowns on page 2. The volumes shown are accepted as final. They have been determined by individual tree measurements and applying Doyle volume tables, with appropriate form class corrections. Allowance was made for defect. Prospective buyers are urged to examine this timber and make their own estimate of quality and quantity. *Please note that the volume for the Youth Camp was cruised by a third party and not TLM Management LLC.*
- **The bid will be a lump sum, combined bid for both properties. The winning buyer shall meet with the Seller's Agent to assign prices to each species. The prices will be assigned for each property owner for a final contract price.**
- All trees marked on the Youth Camp property are marked with a dot of blue paint at breast height and below stump height as included in the sale. The Ross timber is marked with a blue ring around the trees and a dot below stump height.
- Property boundaries along the area of timber sale are flagged with orange or pink flagging by the Sellers agent.
- **The private roadway, if used, shall be maintained during the harvest and reclaimed to as good or better condition, than prior to logging.**
- The purchaser will be required to grade all main roads and to install adequate erosion control measures on all roads and landing at the completion of logging. **No Kentucky 31 fescue is to be used.**
- The period of contract shall be for 24 months.
- **All marked trees are expected to be harvested.**
- All Easements have been secured.
- **Performance bond of \$4,000 is required prior to harvest.**
- PURCHASER shall save and hold harmless landowner and his representatives from any and all claims and list the Upshur County Commission and Upshur County Youth Camp Board as an additional insured on liability policy. PURCHASER shall also provide the following proof of insurance: \$1,000,000 Liability Insurance and Proof of current Workers Compensation Insurance



The Statewide Transportation Improvement Program (STIP) is a financially constrained document that is required to show planned Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) expenditures for federal fiscal years 2020-2025. One of the requirements of funding any project with federal transportation funds is that each proposed regionally significant project or major change to program group size undergoes a public review and comment period. 

Welcome, invocation, introductions: Dr. Reed, Board chair, opened the meeting with prayer. Those present introduced themselves and noted their agency affiliation. Dr. Reed noted that there were 36 new cases of covid identified over the weekend in Upshur County, with a total of 93 within the last week. Also noted initially was that Parish House/Clothesline were taking no donations of items, nor is Goodwill. The pregnancy center is still accepting donations. Status at the Salvation Army is unknown. Someone noted that the Really Really Free Market in Buckhannon has yard sale items to give away, according to their page on Facebook.

Healthy Grandfamilies: The Summer session is wrapping up, with one grandparent participating. Lori and Sarah Campbell will be meeting with social workers and Communities in Schools specialists prior to the Fall session beginning. More families are needed! All elementary schools in the county now have a CIS specialist.

Storage: We're looking for spaces available around the county to store items which the UCFRN needs to set aside rather than house in the office. A 12' x 12' area should accommodate our needs. While the space does not need to be heated, it needs to be dry. If the floor is gravel, we will likely need to store on pallets.

Children's Festival: Debora provided an update on this event, to be held on 9/18/21 from 10 am to 2 pm. The planning committee is still hoping for more organizations to join us. Truck Fest will also be going on at the same time. Everything is free to the children of all ages, but the predominant age range of those who usually attend is from 3 to 12 or 13 years old.


Information sharing:

Next meeting: Monday, September 13, 2021 at 12:00 noon. If held in-person, it will be at the Presbyterian Church.



Carey Wagner informed everyone of a letter received from Carrie Wallace regarding the hold they have on the ARF funds until they receive guidelines as to how they are to be dispersed. In her letter it stated that only emergencies would be addressed.

We were making progress with our water loss bringing it down from 270's a day to the 219's a day, but of course then we sprang another leak and sent it right back up; fortunately the leak was repaired very quickly so it should go back down. 





MONTHLY MEETING

SEPTEMBER 7, 2021-4pm

MINUTES

Held at the District office all Board members were present along with Terry Gould, Manager and Barbara Curry. Also in attendance were Randy Watson of Thrasher Engineering, Brian Zickefoose and William Greene of the Warren District Fire Department and Nick and Adam Ringer of Ringers, Inc.

The minutes of the meeting held in August were read and approved.

Brian Zickefoose and William Greene discussed fire hydrants that needed attention. Some minor and others a little more. The major ones are included in the Hodgesville PSD Improvement Project for which Randy Watson of Thrasher is working on funding for our project. The fire hydrant at the Warren District Fire Station which is owned by the fire station was discussed. The valve to turn off the hydrant can not be located. Terry stated if they can't find, HPSD can help isolate by turning water valves off between the station and the intersection so they can perform repairs. Zickefoose and Greene then left the meeting.

Randy Watson of Thrasher and Terry Gould then held a discussion of the meeting they had earlier that afternoon with Terry Cutright, County Commissioner and Carrie Wallace, County Administrator. Randy stated that with money from the American Rescue Plan and the Infrastructure Council that HPSD may be able to get the 1st phase of the Improvement Project started. Carrie and Terry Cutright stated that the US Treasury has not released their final version of guidelines for the allowable usage for the ARP funds. They did state that HPSD needed to update their request letter so that they had it in hand when guidelines were released. The Board held a discussion as to what improvements and repairs needed to be prioritized first.

Ringers discussed work orders and which leaks were the worse. The Board then discussed which ones they wanted attention first. Hackers Creek leak and the one along Rt 20 at the Cobble Lane are the first two on the list. John Harper with the PSC has been working with HPSD on the Cobble Lane leak.

A discussion was held on the PRV on Gum Mountain that started leaking in August. Terry Gould thanked Randy Watson for his help during this time. Ringers were able to get it back in working condition with Randy's assistance. The invoices from Ringers for this repair and dealing with customers during this crisis was quite large. The Board held a discussion on

approaching First Community Bank to take the loan with them back up to the original \$30,500. That would help with the cash flow until our rate increase is finalized by the PSC. This was approved by a motion from Robert Wright and seconded by Roger Ward to contact First Community Bank to take the loan to the original \$30500.

Terry Gould presented the monthly bills, financial reports and leak adjustments. A motion was made by Roger Ward and seconded by Howard Cutright to approve and pay the bills. Barbara Curry stated that the arrears to the City of Buckhannon is now paid in full as of August 20, 2021.


Terry Gould stated that HPSD is waiting for the final report on the rate increase. HPSD is to set up a new checking account for a CWCR Acct to be used as reserve. The rate increase states how much of a percentage of receivables is to go to that account and also a percentage is to go to Ringers and Atlas until the arrearage is paid in full within 2 years or whichever comes first.


