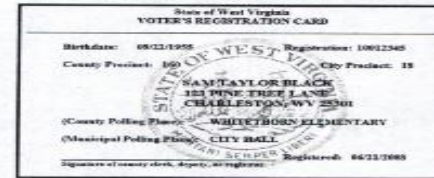

### Acceptable Forms of Non-Photo Identification:

- Voter registration Card
- Medicare card or Social Security Card
- Birth certificate
- WV hunting or fishing license
- WV SNAP ID card
- WV TANF program ID card
- WV Medicaid ID card
- Bank or debit card
- Utility bill or bank statement issued within six months of the date of the election.
- Health Insurance card issued to the voter

### Acceptable Forms of Photo Identification:

- WV driver's license or other WV ID card issued by the DMV
- WV Voter Identification Card
- Driver's license issued by another state
- U.S. passport or passport card
- Military ID card issued by the U.S.
- U.S. or WV Government employee ID card
- Student ID card
- A concealed carry (pistol/revolver) permit

\*Beginning January 1, 2018, voters must show a valid form of identification to vote *in-person* during an Early Voting period or on Election Day in any federal, state, municipal or special election. # ALL VOTERS MUST SHOW IDENTIFICATION

## **Acceptable Forms of Photo Identification:**

- ✓ Driver's license issued by another state
- ✓ U.S. passport or passport card
- ✓ Military ID card issued by the U.S.
- ✓ U.S. or WV Government employee ID card
- ✓ Student ID card
- ✓ A concealed carry (pistol/revolver) permit

If you are a new voter in West Virginia, or this is your first attempt to vote after becoming a registered voter in West Virginia. Under W. Va. Code § 3-2-10, you must present one of the following forms of identification, which shows your current name and residence address. Acceptable forms are:

- Valid photo identification (*e.g.* driver's license)
- Utility bill
- Bank statement
- Government check
- Paycheck
- Any other official government document

**All other voters have the option of showing identification as outlined below:**
