"Family" shall mean persons related by blood or marriage and are presently residing together as a family unit, including any children of 18 years or younger.		
"Greens Fee" shall mean the charge payable to Wakulla County for the privilege of playing one, 18-hole round of golf. The fee is per person, per Round.		
"Junior" shall mean players 18 years of age and under. Walking only.		
"Local Player" shall mean:		
· Current resident of Wakulla, Leon, Jefferson, Liberty or Franklin Counties with proof of residence verified by current valid driver's license or other acceptable identification and documentation.		
· Active and Honorable discharge military members.

· Wildwood RV Park Tenants and Guest.
“Market Mark-Up Rates” shall mean the manufacturer’s suggested retail price plus applicable mark-up. All retail and beverage and concession pricing shall be approved by the Director of Golf.
“Player Development Card” shall mean the charge payable to Wakulla County for an annual (365 days) card that includes Greens Fees for one year. Cart fees are not included in the Player Development Card program. Cart Fees will be charged separately to each player development card holder and guest at a rate of \$25 per round per person.
“Raincheck” shall mean a credit issued for the number of holes a player is unable to play due to a weather event. This applies only to daily round players. To redeem, the player must present the raincheck issued by Wakulla Sands Golf Club.
“Round” shall mean one continuous game consisting of 18-holes of golf.
“Wakulla Schools Golf Team” shall mean a current, valid member of Wakulla County public schools or private schools located in Wakulla County, as verified by the applicable school.
“Weekday” shall mean Monday, Tuesday, Wednesday, Thursday excluding Federal and State Holidays.
“Weekend” shall mean Friday, Saturday, Sunday and Federal and State Holidays.
“Wildwood RV Park Tenants and Guest” shall mean tenants and guest occupying spaces within the adjacent RV Park only. As per Greens Fee Agreement dated December 13, 2021, which expires December 31, 2026, Wildwood RV Park Tenants and Guests will receive a 50% discount on the current daily green fees on weekdays and a 25% discount on the current daily green fees on weekends with valid proof that they are a Wildwood RV Park Tenant or Guest. The RV Park Owner shall provide the County with a daily guest register, which shall serve as valid proof of Wildwood RV Park Tenant or Guest status. Wildwood RV Park Tenants or Guests may only make same day tee time reservations; advance tee time reservations will not be permitted. The Wildwood RV Park rate is calculated by discounting the “Daily Greens” fee then adding the Golf Cart Fee.
