This addendum is being posted to provide further guidance for firms who have submitted a proposal to Wakulla County in response to RFP 2023-20.

Section 6 of RFP 2023-20's scoring criteria was posted incorrectly. This RFP will be based solely on unit pricing in order to be in compliance with FEMA reimbursement requirements. The criteria for scoring evaluation found in 6.6 of the RFP is hereby deleted. As stated above, this RFP will be awarded to the lowest most responsive responsible bidder(s) solely on unit pricing. The County shall determine the lowest bid(s) by adding up and totaling the individual unit prices to come up with a base bid amount. The County reserves the right to award bids to multiple contractors and cannot guarantee any contractor an amount of work it may or may not receive as part of any award. The County may conduct such investigations as it deems necessary to confirm that the proposers have met the minimum requirements of the RFP to determine the responsiveness of the proposal.

At this time, ALL sealed cost proposals remain sealed and are not available for disclosure. Based on the above, Wakulla County is providing firms who have already submitted a cost proposal for RFP 2023-20 the following options:

- Submit a new unit pricing proposal, on or before 3:00pm June 29, 2023;
- Inform the county in writing, on or before 3:00 pm June 29, 2023, that they would like to keep the cost proposal as previously submitted; or
- Inform the county in writing, on or before 3:00 p.m. June 29, 2023, that they are withdrawing their cost proposal.

No sealed cost proposals shall be opened by the County until after 3:00 p.m. June 29, 2023. There will be no oral presentations required for this RFP. The proposals shall be opened on the time and date stated in the schedule of events at a publicly noticed in person meeting that is open to the public. Although proposers are not required to be present at the opening, to accommodate those proposers that desire to attend and cannot make it in person, the County will provide a virtual option by which proposers may attend the meeting.
