Preference shall be given to businesses with drug-free workplace programs. ** The bike trails are to be mowed, string trimmed with weed eaters, and blown off on a biweekly basis beginning in March through the end of November each year. Along with those tasks the bike trails (asphalt) must be edged once in March and again in August. Edging around all hardened surfaces concrete, either natural or constructed shall be performed monthly. An approved herbicide should be used to kill weeds growing in the trail and/or aprons.

*** The bike trails are to be blown, clean and any general maintenance performed beginning in December through February. No mowing is to be done during this time. There are two required visits per month.

**** The flower beds along US-98 bike trail will require quarterly flower bed maintenance to include clipping shrubs as needed and the debris removal associated with this task, weed removal by hand or chemical application, and quarterly pine straw installation at the beds
