Consideration will be given to the vendor who has the capability to perform the work or supply the commodities or equipment, consideration shall also be given to the vendor's geographic proximity to Wakulla County for future ease of delivery, mobilization, or customer support after a purchase. The lowest cost, responsible and responsive vendor who is capable of performing the services or supplying the commodities or equipment shall be awarded the contract.

Purpose:

The Board of County Commissioners is seeking written quotes from licensed and insured flooring contractors with the required expertise and capability to install an epoxy flake floor system at the Wakulla Sands Golf Club Concession Building located at 3874 Coastal Highway, Crawfordville, Florida 32327.

Scope of Services to be provided:

Contractor will complete the following scope of work:

- Grind, prep, fill cracks/voids
- Install an epoxy flake floor system
- Apply a polyaspartic top coat with heavy anti-slip

Time and Deliverables:

The selected vendor shall be expected to complete all necessary and required services pursuant to this quote. This quotation is for the installation of an epoxy flake floor system at the Wakulla Sands Golf Club Concession Building.

If the vendor requires extending time of completion due to material lead time, the vendor must request an extension in writing to the Procurement Office.

The estimated time of completion for this project is 7 days.

Warranty:

Upon award of the written quotation the vendor will be required to provide the necessary liability insurance as per County requirements.

REQUEST FOR WRITTEN QUOTE – WAKULLA SANDS GOLF CLUB CONCESSION BUILDING FLOORING SERVICES

The following minimum levels of insurance required are as follows:

- **Comprehensive Automobile Liability.** Insurance with \$1,000,000.00 combined single limit of liability for bodily injuries, death and property damage resulting from any one occurrence, including all owned, hired, and non-owned vehicles, as appropriate.
- **Commercial General Liability.** \$1,000,000.00 combined single limit of liability for bodily injuries, death and property damage, and personal injury resulting from any one occurrence.
- **Umbrella (Excess) Liability Insurance.** Umbrella Liability with limits of not less than \$1,000,000.00, exclusive of defense costs, to be in excess of all other coverages. Such coverage shall be at least as broad as the primary coverages above, with any excess umbrella layers written on a strict following form basis over the primary coverage. All such policies shall be endorsed to provide defense coverage obligations.
- **Professional Liability Insurance.** \$1,000,000.00 for design errors and omissions, exclusive of defense costs. CONTRACTOR shall be required to provide continuing Professional Liability Insurance to cover each project for a period of two (2) years after the project is completed.
- **Workers' Compensation.** The CONTRACTOR shall provide, pay for, and maintain workers' compensation insurance on all employees, its agents or subcontractors as required by Florida Statutes
